## Resolution Text

*Resolved*, the House of \_\_\_\_\_ concurring,

That the 81st General Convention, as people of faith who believe that all people are created in the image of God, advocate for Migration with Dignity, a statement of general principles about migration that champion equal and respectful treatment of all people, which follow directly from the teachings of Jesus and our baptismal promise to “respect the dignity of every human being,” while aligning with the world’s other great religions and principled humanism; and be it further

*Resolved*, that, acknowledging that grave and serious mistreatment of ethnic minorities, migrants and refugees is currently on the rise in the midst of record migration across international borders, the 81st General Convention, consistent with previous resolutions of the General Conventions of The Episcopal Church, declare itself to be in support of Migration with Dignity for all migrants, including refugees, asylum seekers, displaced persons, and those who cross borders in search of opportunity, including the following human rights within the Migration with Dignity framework:

**A universal right of movement**, including freedom to leave and return to one’s country of origin, freedom of movement within one’s country of origin or country of settlement.

**The right to be secure:** from sexual violence including rape and sexual exploitation, human trafficking, slavery, forced labor and arbitrary and abusive detention.

**The right of equality,** to include: 1) equal treatment with no discrimination under the law based on color, gender, sexual orientation, language, religion, political affiliation, national origin; and 2) equal opportunity for upward mobility.

**Rights to a basic quality of life,** including employment rights, housing rights and food rights.

**The right to access services** such as health care, education and legal representation.

**Civil and political rights** guaranteeing the right to identity, to use of one's language, and to freedom of speech and religion.

And be it further

*Resolved,* That the 81st General Convention affirm Migration with Dignity as a framework to guide ministry with migrants, calling upon all Episcopalians, congregations, and dioceses to make urgent efforts through direct action to support arriving migrants' immediate needs for shelter, food, clothing, legal assistance, etc. and to advocate that local, state, national, and international governing bodies promote Migration with Dignity by enforcing existing laws and policies that uphold these principles on behalf of refugees, migrants, asylum seekers, and displaced persons, and by enacting new laws and policies guaranteeing their welcome, protection, and integration into our common human journey; and be it further

*Resolved,* that the 81st General Convention call upon the Office of Government Relations and the church's UN Mission to continue and reinforce their efforts to support the Global Compact for Migration and other international frameworks that are consistent with the general principles stated in Migration with Dignity; and be it further

*Resolved,* that the 81st General Convention direct the Presiding Bishop and President of the House of Deputies to establish a Task Force on Migration with Dignity (MWD) to build on and expand migration ministries in the Episcopal Church and to develop a strategic plan for coordinated, global Episcopal ministry consistent with MWD principles for all migrating persons at all stages of migration. The task force will be instructed to:

- Inventory current assets and resources for serving and supporting migrants, church-wide
- Conduct a gap analysis to identify missing elements that could strengthen the church's response
- Recommend a coordinated whole-of-church strategy to strengthen our support for migrants, consistent with this resolution;

And be it further

*Resolved*, that the Task Force on Migration with Dignity consist of no more than 14 members who have direct experience with migration and/or are actively involved in migration-related ministry in the Episcopal Church, and who represent all Provinces, especially those with dioceses outside of the U.S. A minimum of three Bishops shall serve on the Task Force, and be it further

*Resolved*, that the Task Force report to Executive Council annually during the Triennium and to the 82nd General Convention; and be it further

*Resolved*, that the General Convention request a budget allocation of \$54,000 for the implementation of this resolution.

## **Explanation**

This resolution is needed as a positive general statement, reaffirming and updating the Episcopal Church's overall, long-standing commitment to human rights as they pertain to just treatment of the world's refugees, asylum-seekers, and all migrants.

The resolution is deeply grounded in Scripture. No moral guidance is more clearly articulated in both Biblical testaments than the need to "welcome the stranger." A few examples:

Old Testament: "Don't mistreat any foreigners who live in your land. Instead, treat them as well as you treat citizens and love them as much as you love yourself. Remember, you were once foreigners in the land of Egypt. I am the Lord your God" (Leviticus 19:33-34).

New Testament: "Be sure to welcome strangers into your home. By doing this, some people have welcomed angels as guests, without even knowing it." (Hebrews 13:2)

Jesus's second great commandment: "Love your neighbor as yourself."

All six of the key elements of the resolution align with, and can be derived from, the United Nation's Universal Declaration of Human Rights (1948). They are also fully consistent with more recent international frameworks, such as the New York Declaration for Refugees and Migrants, the UN Global Compact for Migration, the Global Compact on Refugees and the Global Refugee Forum. These are attached as supporting documents. The Episcopal Church has consistently supported these landmark statements and agreements.

The resolution also accords with and supports key positions of the Anglican Communion. As set forth in the Lambeth Human Dignity call of 2022, actions against the human dignity of God's children, including those against migrants and refugees, are sin, and hospitality to all and faithfulness to each are key marks of a godly community (1 Pt. 4:8-10). This statement is attached as a supporting document,

As a single, clear and direct positive statement of principle, the resolution draws together positions that have been affirmed in more than 50 General Convention and Executive Council resolutions over the years. Its concision and clarity will help us communicate our

church's stance more effectively, build support, and work alongside other pro-migrant organizations toward a world in which fundamental human rights extend to all people. A listing of the previous resolutions that support Migration With Dignity, with links to their full text, is attached as a supporting document. Many of these previous resolutions advocate government action; the Migration with Dignity principles establish rights of migrants that can serve as the basis of advocacy for just and compassionate government policies and practices and as a guiding foundation for action by dioceses, congregations, and individuals in The Episcopal Church.

The resolution, taken as a whole, defines a much-needed, innovative response to the increasing challenge of global migration. Current approaches have proven inadequate to this challenge. Grave and serious mistreatment of ethnic minorities, migrants and refugees currently on the rise both in the United States and globally in the midst of record migration across international borders. The number of international migrants grew to 281 million in 2020, meaning that 3.6% of the world's people lived outside their country of birth that year, according to the United Nations' International Organization for Migration (IOM).

The Migration with Dignity framework is presented and discussed in greater detail in two articles published in 2022 in the Journal of Disaster Research, which are attached as supporting documents.

The budget for the proposed Task Force on Migration with Dignity breaks down as follows:

Two in-person meetings for 14 people:

Two, two-and-a-half day meetings @ \$1,700 per person = \$47,600.

Total: Round up to \$50,000 due to international travel costs.

Strategic planning consultant:

Two meeting days @ \$800 per day = \$1600

Travel costs for meeting = \$1700

Administrative work @\$700/day = \$700

Total: \$4,000

Task Force budget total: \$54,000

**Resolution Number:** 2022-D045  
**Title:** Support the Protection of LGBTQI+ Refugees and Asylum Seekers  
**Legislative Action Taken:** Concurred  
**Final Text:**

***Resolved, That the 80th General Convention of the Episcopal Church express its full support of the UNHCR (United Nations High Commissioner for Refugees) and IOM (International Organization for Migration) in their mission to protect LGBTIQ+ persons forced to seek refugee or asylee status because they fear being persecuted based on their sexual orientation, gender identity, gender expression and/or sex characteristics (SOGIESC); and be it further***

***Resolved, That the General Convention urge all nations, especially the United States, to actively accept vulnerable SOGIESC refugees and asylees, and not send them back to their countries of origin , where they face persecution, violence, prison and possible death; and be it further***

***Resolved, That the 80th General Convention request that the Episcopal Migration Ministries highlight the issues surrounding LGBTQI+ refugees and asylees and offer information on ways of support, including these, for example, in their Toolkit for Congregations.***

**Resolution Number:** 2022-D090  
**Title:** Reaffirm the Church's Teaching on Racism  
**Legislative Action Taken:** Concurred as Amended  
**Final Text:**

*Resolved, That the 80th General Convention of The Episcopal Church reaffirms previous General Convention resolutions on racism and that these shall be considered part of the Church's teaching on racism; and be it further*

*Resolved, That the General Convention thanks the House of Bishops Theology Committee for the teachings on racism and white supremacy and commends them to the church for study and action; and be it further*

*Resolved, That the Church's Christian principles to guide responses to human migration (2018-D009) and all previous General Convention resolutions concerning migrants and migration shall be part of the Church's teaching on racism; and be it further*

*Resolved, That racism, racially-biased behavior, and teaching contrary to the Church's teaching on racism is an anathema to the Church.*

**Resolution Number:** 2018-C033  
**Title:** Denounce Racism Against Immigrants and Advocate for Immigration Reform  
**Legislative Action Taken:** Concurred as Amended  
**Final Text:**

*Resolved, That the 79th General Convention of The Episcopal Church reject and deplore racist and unjust treatment of immigrants of any residential status; and be it further*

*Resolved, That the Episcopal Church reaffirm GC2009-B006 which advocates for comprehensive immigration reform; and be it further*

*Resolved, That The Episcopal Church direct the Episcopal Office of Government Relations to advocate on this Church's behalf all elements of this resolution; and be it further*

*Resolved, That The Episcopal Church advocate through education, communication, and representation before legislative authorities the continuation of Temporary Protective Status (TPS) for all persons fleeing to or currently resident in the US seeking refuge from violence, environmental disaster, economic devastation, or cultural abuse, domestic abuse, or other forms of abuse; and be it further*

*Resolved, That The Episcopal Church advocate for congressional consideration and implementation of comprehensive immigration reform which will allow millions of undocumented immigrants who have established roots in the United States and are often parents and spouses of U.S. Citizens to have a realistic pathway to citizenship and to full social and economic integration into the United States; and be it further*

*Resolved, That we affirm comprehensive immigration reform to include:*

- **Keeping families together**
- **Respecting the United States Bill of Rights**
- **Honoring Human and Worker Rights**
- **Providing a Pathway to Citizenship**

*And be it further*

*Resolved, That the General Convention 79 support the goals of expanded immigration relief for youth as outlined in the Deferred Action for Childhood Arrivals (DACA) as stated in GC2015-D048; and support the passing of federal legislation that presents a pathway to citizenship for undocumented youth and young adults known as DREAMers, as stated in GC2012-D067; and be it further*

*Resolved, That we urge dioceses, congregations, and individual Episcopalians to commit to long term advocacy, prayer, and study around immigration and partner with the Office of Government Relations to contact their elected officials on the need for compassionate and humane immigration reform through the Episcopal Public Policy Network.*

*Resolved, That The 79th General Convention commends the ongoing work of Episcopal Migration Ministries in resettling refugees to the United States on behalf of the Episcopal Church and encourages dioceses, parishes, and communities to engage the work of Episcopal Migration Ministries through its Partners in Welcome ministry network and other welcoming and advocacy programs.*

**Resolution Number:** 2018-D009  
**Title:** Set Forth Christian Principles to Guide Responses to Human Migration  
**Legislative Action Taken:** Concurred as Amended  
**Final Text:**

*Resolved,* That the 79th General Convention of The Episcopal Church recognize that human migration has always been part of the human condition, and that human migration will continue in future, and will likely increase due to any number of variables including the effects of climate change on human habitat, economic instability, or ongoing war and conflict, and remembering the call in both Hebrew and Christian Scriptures to welcome the stranger, building stronger and more diverse community: “You shall also love the stranger, for you were strangers in the land of Egypt” (Deuteronomy 10:19) and “I was a stranger, and you welcomed me; .... Truly I tell you, just as you did it to the least of these who are members of my family, you did it to me” (Matthew 25: 35, 40); and be it further

*Resolved,* That this General Convention set forth these principles to guide our church’s response to human migration, including internal migration, in the future:

1. We recognize the fundamental human rights of all people as expressed in our Baptismal Covenant and we reaffirm that the Universal Declaration of Human Rights applies to all refugees and both regular and irregular migrants;
2. We remember that Mary, Joseph, and Jesus were refugees, as they were forced to flee into a foreign land to escape violence;
3. We call on all governments to keep their commitments and legal obligations to respect the rights and dignity of all people, including access to justice and social services, while recognizing the complexity of developing just immigration policies in any country, and the legitimate need to protect borders and address security threats to sovereign nations;
4. We commit the church to learning and engaging migration issues as part of the Jesus Movement, sacredly holding the voices and leadership of migrants themselves and honoring their leadership in this process;
5. We will endeavor to learn and address root causes of migration and advocate for just solutions with Anglican/Episcopal, ecumenical, and interfaith partners;
6. We acknowledge the connection between U.S. policies, and the policies of other states, and the root drivers of migration, including climate change, armed conflict, and disruption of local economies through global trade policies;
7. We stress the importance of demonstrating hospitality and welcome as Christian values at the local level, preaching hospitality and positive storytelling to overcome xenophobia;
8. We insist that the United States of America and other powerful, wealthy nations, and all nations to the best of their ability, contribute to resettlement, establish and maintain safe and orderly humanitarian protection for refugees, internally displaced persons, and other migrants seeking long-term solutions and safety;
9. We call on all nations to maintain family unity and safety during migration;
10. We insist that economic and foreign relationships among governments should not increase the need of migration due to economic hardships, persecution, and violence;
11. We insist that governments strive to maintain conditions which are conducive to internal stability and employment opportunity;

12. **In the event that people are forced to migrate, we insist that our governments address the drivers holistically, without racial, ethnic, socioeconomic status, sexual orientation, gender identity, physical or mental ability, health status, or religious prejudice;**
13. **We insist that our governments adhere to the internationally accepted principle known as non-refoulement, that stipulates that countries should not return migrants and refugees to unsafe conditions in their home countries or other countries;**
14. **We recognize the links between migrants in vulnerable transit situations and human trafficking and other dangers, and will seek to establish and maintain robust, safe, and orderly routes for refugees;**
15. **We urge governments to expand refugee resettlement as a humanitarian response that offers individuals safety and opportunity;**
16. **We recognize that displacement due to climate change already happens and will increase, and we insist that our governments and the international community must commit to development of long-term protection solutions for persons displaced by climate change; and be it further**

*Resolved, That this General Convention recognize the process underway at the United Nations to establish a Global Compact on Refugees,[i] and a Global Compact on Migration, processes that have included advocacy by The Episcopal Church Representative to the UN and by the Office of Government Relations Refugee and Immigration Policy Advisor; and be it further*

*Resolved, That this General Convention urge the Office of the Presiding Bishop to ensure continued representation of The Episcopal Church at the United Nations and other multinational consultations with faith communities on refugee and migrant issues, alongside the Anglican Communion Office, Lutheran World Federation, and other ecumenical and interfaith partners in responding to the global refugee crisis; and be it further*

*Resolved, That this General Convention encourage all congregations and dioceses to learn about the intricacies of migration, including root causes through the resources provided by Episcopal Migration Ministries and its Partners in Welcome network and engage in aiding migrants to the best of their ability.*

**Resolution Number:** 2015-D079  
**Title:** Urge Church-Wide Assistance to Undocumented Persons  
**Legislative Action Taken:** Concurred as Amended  
**Final Text:**

*Resolved, That the 78th General Convention strongly urge dioceses and congregations to provide resources and education for undocumented persons and their families to learn about their legal rights, including their rights regarding certain immigration relief such as asylum; and be it further*

*Resolved, That the Joint Standing Committee on Program, Budget and Finance consider a budget allocation of \$10,000 for the implementation of this resolution.*

**Resolution Number:** 2012-B028  
**Title:** Reform Refugee Policy  
**Legislative Action Taken:** Concurred  
**Final Text:**

*Resolved, That the 77th General Convention of The Episcopal Church urge the United States Congress to reform the Refugee Act of 1980 in order to modernize the nation's refugee resettlement program; and be it further*

*Resolved, That such modernization efforts include but not be limited to, meeting the urgent needs of a diverse refugee population through specialized and extended case management, culturally and linguistically appropriate mental health services, recertification assistance for refugees with a professional background, restoration of federal benefits from 8 months to at least one year, housing and transportation assistance, and other innovative policies that create an adaptive, sustainable, and effectual integration pathway for refugees that helps them reestablish their lives in welcoming communities and live to the full potential of their talents and abilities in freedom and safety; and be it further*

*Resolved, That The Episcopal Church, in response to our baptismal covenant's call to strive for justice and peace among all people and respect the dignity of every human being, as part of the Anglican Communion work to identify emerging refugee crises on the ground and to lift up populations who lack access to durable solutions, including resettlement and amplify their voices to local and global decision makers.*

**Resolution Number:** 2006-A017  
**Title:** Adopt the Principles of “The Alien Among You” as the Church Policy  
**Legislative Action Taken:** Concurred as Amended  
**Final Text:**

*Resolved, That the 75th General Convention of The Episcopal Church receive “The Alien Among You” in the Blue Book Report of the Standing Commission on Anglican and International Peace with Justice Concerns; and, while recognizing the duty and right of a sovereign nation to protect and defend its borders, adopt the following fundamental principles included in “The Alien Among You” as the policy of The Episcopal Church.*

1. **Undocumented aliens should have reasonable opportunity to pursue permanent residency.**
2. **Legal workers should be allowed to enter the United States to respond to recognized labor force needs.**
3. **Close family members should be allowed to reunite without undue delay with individuals lawfully present in the United States.**
4. **Fundamental U.S. principles of legal due process should be granted all persons.**
5. **Enforcement of national borders and immigration policies should be proportional and humane; and be it further**

*Resolved, That the 75th General Convention of The Episcopal Church deplore any action by the Government of the United States which unduly emphasizes enforcement, including militarization of the border between the United States and Mexico, as the primary response to immigrants entering the United States to work; and be it further*

*Resolved, That The Episcopal Church undertake a campaign to educate Episcopalians as to the plight of refugees, immigrants, and migrants, which will include information about the root causes of migration; and be it further*

*Resolved, That this campaign call the Church to commit to welcoming strangers as a matter of Christian responsibility, to advocate for their well being and protection and to urge its members to resist legislation and actions which violate our fundamental beliefs as Christians, including the criminalization of persons providing humanitarian assistance to migrants.*

**Resolution Number:** 2006-D073  
**Title:** On the Topic of Asylum for Persecuted Lesbian and Gay People  
**Legislative Action Taken:** Rejected [Died with Adjournment]  
**Text of Resolution:**

*Resolved*, the House of Deputies concurring, That the 75th General Convention of The Episcopal Church note with concern that homosexuality and the advocacy of equal treatment for gay men and lesbians is being criminalized in various countries around the world and that in addition to formal criminalization there is increasing violence against lesbians and gay men who are denied the protection of governments; and be it further

*Resolved*, That in light of such criminalization and lack of police protection that the government of the United States be encouraged to grant asylum to those whose advocacy of homosexuality is illegal in their home countries or whose lives are threatened for this reason; and be it further

*Resolved*, That The Episcopal Church aid in the resettlement of such individuals; and be it further

*Resolved*, That the Convention commend groups aiding persons seeking asylum in the United States because of serious intolerance of their sexual orientation.



**Resolution Number:** 1997-C017  
**Title:** Support Asylum Rights of Women Fleeing Mutilation  
**Legislative Action Taken:** Concurred as Amended  
**Final Text:**

*Resolved, That this 72nd General Convention support the rights of women fleeing the practice of female genital mutilation (female circumcision) to be granted refugee status and, when seeking such protection in the United States, be granted asylum.*

**Resolution Number:** 1985-D113  
**Title:** Request Congress to Reform Immigration Legislation  
**Legislative Action Taken:** Concurred As Amended  
**Final Text:**

*Resolved, That this 68th General Convention, as it has in the past, call upon Congress to enact immigration legislation of a positive nature that will recognize human realities of the millions of undocumented people in the country, provide for appropriate asylum and safe haven for those fleeing political repression from abroad, and will eliminate the many repressive features contained in the present Senate bill, S. 1200; and be it further*

*Resolved, That copies of this Resolution be transmitted to all members of the United States Senate, and to the members of the Judiciary Committee of the House of Representatives; and be it further*

*Resolved, That all deputies to this Convention, as individuals and through the appropriate social concerns committees of their churches, write to their respective United States Senators.*
